### School Fees (Per Term)

Reception to Year 2 (Ages 4 - 7)	£9,390

We currently offer the Government's Funded Early Education Scheme of 15 hours universal entitlement for all 3-and 4-year olds. These hours are 08:30-11:30 daily.

### Notes:

1. Drama and Music lessons are taken once a week and are charged in arrears at the end of each term. The charge will be adjusted if children take longer lessons, or more than one lesson a week.
2. A half term's notice in writing must be given to the Director of Music or the Head of Drama if lessons are to be given up or a term's fees are payable in lieu. This does not apply to the first term, which is probationary.
3. Similar charges are made for children invited to take individual singing lessons, but there is no charge for choirs or orchestra.
4. It is expected that every pupil will make a commitment to practise their instrument regularly. Instrumental teachers will advise on the recommended time to be spent per day on practice, according to the pupil's age, ability and instrument.
5. Parents/Guardians might wish to consider hiring an instrument from a music shop in the first instance. This applies as much to piano as any other instrument. Please note that lessons will not be given to pupils who are not able to practise at home.

### Expeditions and Residential Trips

These are billed as extra in arrears. The costs differ depending on the type, length and location of the trip and they are published in advance.

### Stationery

Text books and stationery are provided free. However, the school reserves the right to charge for specific items if the Head deems that the child requires them. Such items are issued centrally and charged to parents.

### Payment of Fees

1. School fees are due on, or before, the first day of term.
2. A late charge fee of £170 is made for all fees remaining unpaid 14 days after the beginning of term. We may charge interest on the overdue amount at the rate of 1.5% per month.
3. Pupils may be excluded if fees remain unpaid at half term.
4. Notice of the withdrawal of a pupil must be given in writing to the Head not later than the first day of the term before the term to which the notice relates to. Otherwise the following term's fees are payable in lieu of notice.
